2 Committee Governance

Appointment of Chair

3 Confirmation of Previous Minutes

5 Strategic Activities

5.1 Standing item- Update on Carbon Targets

Peter Lisle – WCC Sustainability Team Leader updated the Committee that Council's corporate carbon target is net zero emissions by 2025. Given the Nov 2022 updated net zero guidelines formulated by International Standards Organization it will be challenging for Council meet net zero emissions by 2025. The target is currently under review internally.

5.2 Matters for discussion

NSW rebates for heat pumps in Willoughby raised by Janet

France:

Peter Lisle – WCC Sustainability Team Leader briefed the Committee

that Council will review promoting domestic hot water heat pump

technology in 24/25, ascertain any rebates available and look to

promote further on the Council website alongside the Solar Bulk Buy

Program currently available.

Councillor John Moratelli noted that hot waterheat pump systems have

a smaller carbon footprint for equal capacity and presented medium to

longer terms financial savings too. The Committee suggested

explanatory signage be provided at the Leisure Centre as heat pumps

will be used to provide heating and other sustainability initiatives

adopted by the Centre. Peter Lisle said this this will be considered by

staff once the Centre is reopened.

Presentation by Council's wildlife officer on matters raised by

Eva Coulam:

Simon Brown - WCC Wildlife Officer gave a presentation on the

following issues:

rodenticides

Council use of pesticides:

Currently Council does use a range of pesticides for the control feral

animal (including fox and rabbit). WCC staff and contractors are

required to have "Chemcert" training to use any pesticides. WCC staff

and contractors have completely stopped using second generation rodenticides 10 years ago. Since 2014, we have requested contractors

to stop using second generation rodenticides. Rat baits like "Racumin"

(Coumatetralyl, a first-generation anticoagulant) are currently being

used in all WCC properties that require rat control. A program from

birdlife Australia is calling out suppliers of second-generation supplying

these

chemicals.

The Committee made the following recommendation:

Recommendation: That the Committee recommends that Council

require contractors not to use 2nd gen pesticides and that Council

circulate material from Birdlife Australia not to use rodenticides and

ensure the contractors are monitored for compliance.

Moved by Eva Coulam and seconded by Rena Czaplinska-Archer

Weed control:

Simon Brown further briefed the Committee that there are lots of

herbicides used for the management of weeds in Willoughby. All

pesticide requires regular documentation of use.

Janet France commented that Council is moving towards more eco-

friendly solutions.

Simon Brown noted that weed control techniques vary considerably

from site to site and depend on various factors, but soil condition and

natural resilience are key factors. The revegetation sites at Flat Rock

Gully comprise heavily disturbed soils with no natural resilience.

Consequently, there is little to no natural regeneration of native plants

but regular and ongoing outbreaks of weed species.

In contrast, sites like Blue Gum Reserve are less disturbed, even

along some of the degraded edges, and there are often more sources

of native seed and natural recruitment. Consequently, traditional bush

regeneration techniques that do not require ongoing herbicide spray

regimes are more effective.

Fox Control:

Simon Brown noted that 1080 (Sodium fluoroacetate) is a very

easy/inexpensive option. There are of course other options including

trapping programs which have not been very successful. Over the last

six years council has carried out shooting programs with professional

shooters in partnership with local golf course managers. This is more

expensive than baiting but has a similar effect in reducing fox numbers

in areas being treated.

Fox numbers are being reduced as a result of 1080 use. 1080 is used

in the New Zealand to control possums however the concentration of

1080 in those baits is much higher than what is used to control foxes.

Native fauna has a high resistance to 1080 which is why it is used in

Australia. The possibility of them being poisoned by the low

concentrations in the baits used for foxes is very low and the bait

stations are also constantly monitored to further reduce risk.

He further noted that shooting is by far the most humane measure and

have been doing this for six years mainly limited to golf courses and

large ovals. Also using soft jaw leg hold and cage trapping. Cage traps

have been found to be not very effective. 1080 is still an essential tool

for controlling foxes in Willoughby and has been used since 2001.

During that time, baiting has occurred over two, four-week periods

each year in conjunction with members of the Sydney North

Vertebrate Pest Committee, including 9 councils and state government

agencies, LLS, DPI and NPWS. Willoughby has over 30 baiting

stations that have been approved for the use of 1080 poison baits.

Over the last five years, Willoughby Council has reduced the number

of locations where 1080 is used and has increased the use of other

controls, such as trapping and shooting. In early 2023, 1080 poison

baits were used at only two locations. 1080 has not been used again

after that and will not be used to control foxes in 2024.
