## 4 Actions from Previous Meetings

The Committee unanimously resolved to note the actions of previous meetings contained in the agenda, with the following change:

Wendy Norton noted that the Committee were still committed to organising a seminar/webinar on preventing the abuse of vulnerable people.

Mark Tonga stated there are major changes to the NDIS around people with disability who are over 65 and what that means for them moving forward. Committee agreed that might be a good topic for the seminar/webinar.

Community Venues & Services Team Leader suggested the Committee wait until after the Seniors Festival and use feedback from events to see if there was a topic of interest that had not been covered and would be of interest to the Committee.

Chair requested Wendy Norton to reconvene the group and hold an informal meeting again to determine what outcome the Committee would like to achieve from the seminar/webinar

## 5 Strategic Activities

#### 5.1 Standing item - Reconciliation Action Plan

Community Venues and Services Team Leader informed the Committee the Draft Reconciliation Action Plan has gone back to Reconciliation Australia for the final approval.

## 5.2 Community Engagement Strategy

Council's Community Engagement Specialist gave a presentation on Council's Community Engagement Strategy Policy and the development of the Community Engagement Strategy Implementation.

The Committee members made a number of following observations:

- Wendy Norton raised concern about sharing information with US based company Granicus.
- Mark Tonga stated the community is concerned about the digital shift and suggested more face-to-face sessions and interactions with people with disability would be of more benefit.
- The Committee agreed that face-to-face interactions are better from an inclusive perspective
- Wendy Norton noted the original Have Your Say platform allowed access to other people's responses which was valuable as it provided a broader context for responding.
- Mark Tonga suggested that the Toolkit be co-designed with people with disability so staff had a greater understanding of how to reach more vulnerable communities.

- Srishti Mahhajan suggested Council undertake some community engagement activities in supermarkets because of their large reach within the Community. The Committee agreed.
- Councillor Greco suggested using the City News publication.
- Margaret Kay suggested targeted training for Customer Service staff on using the correct language when speaking to people with disability.

The Community Engagement Specialist thanked the Committee for their time and input.

#### 6 **Other Business**

#### **State Government Planning Reforms.**

Chair raised concerns around State Government planning reforms and the impact this would have on Willoughby especially in relation to Affordable Housing.
