## **RE : ITEM - 15.9 Artarmon Parklands Pavilion**

Council's Report states :

'..Council has commissioned two separate and independent heritage reviews of the existing club building both of which identified that the building did not meet the warrants of local heritage protection..'

This is at odds with advice from the NSW Heritage Council (11Sept 2019, copy attached) which states :

'The State Heritage Register Committee considered the likely level of significance of the Artarmon Bowling Club, based on the information provided, to be of local significance..'

- Mr Arnott has advised that a formal assessment of the item is underway. It is therefore possible that the assessment will find for local significance.
- If found to have this significance it can be expected that recommendations would involve the built form, i.e. subject of this DA
- Why give consent to lodging a 'conceptual' DA whose physical form is likely to be the subject of forthcoming recommendations?

I am respectfully requesting that Councillors withhold owners consent until such time as they have received and considered the implications of the LHI Assessment.
