7.1 REFERRAL OF DRAFT FINANCIAL REPORTS FOR THE YEAR ENDED 30 JUNE 2022 TO EXTERNAL AUDIT

- 1. Note that the draft annual financial reports for Willoughby City Council for the period 1 July 2021 to 30 June 2022 have been prepared in accordance with the Local Government Act 1993, the Local Government (General) Regulation 2021, the Australian Accounting Standards and the Office of Local Government prescribed Code of Accounting Practice and Financial Reporting 2021/22.
- 2. Adopt the draft accounts and authorise the Mayor, Deputy Mayor, Chief Executive Officer and Chief Financial Officer to sign the Statement by Councillors and Management as required under Section 413 (2)(c) of the Local Government Act 1993 and Clause 215(1) of the Local Government (General) Regulation 2021.
- 3. Resolve for the purposes of Section 413(1) of the *Local Government Act 1993* to refer the draft financial reports for the period from 1 July 2021 to 30 June 2022 to the NSW Auditor General (Council's independent auditor) for external audit.
- 4. Resolve, for the purposes of section 417(5) of the *Local Government Act* 1993 to send a copy of the audited financial reports and a copy of the auditor's report to

the Office of Local Government and the Australian Bureau of Statistics immediately on receipt of the independent Auditor's Reports.

- 5. Resolve that the financial reports be placed on public exhibition for 7 days between 27 October 2022 and 3 November 2022 and that public notice be given of the presentation of the financial reports as prescribed by Section 418 of the Local Government Act 1993.
- 6. Resolve that 28 November 2022 be fixed as the date for the public meeting to present the audited financial reports and the audit reports for the year ended 30 June 2022 as required by Section 419 of the *Local Government Act 1993*.
- 7. Resolve to accept submissions on the financial reports and audit reports and refer these submissions to the auditor in accordance with Section 420 of the Local Government Act 1993.
